

# Worthing Archaeological Society

Committee Meeting Minutes held on Monday 17<sup>th</sup> June 2019  
at 5 Smuggler's Walk, Goring

1. **Apologies:** Ms Amie Friend, Mrs Gill Turner, Mrs Teresa Griffiths, Dr Jacquie Lake, and Mr Keith Bolton
2. **Minutes of the Last Meeting** were accepted.
3. **Matters Arising:** Under 13a Mrs Lane did not bring any books out for sale on the Sompting dig due to the inclement weather and Mrs Griffiths has not attended Salvington Windmill's public openings in order to sell books due to family commitments.
4. **Field Unit Update**
  - a. **Slindon Field 20:** Mrs Turner advised by email that she will be cataloguing all the finds for the site archive and then with Bob start on the specialist Flint Report. **Action: GT**
  - b. **Slindon Stable Yard:** Mr Bob Turner, Mrs Connie Shirley and Mrs C Hutchins met with Ms Katie Archer and Mr Richard James of the National Trust to confirm arrangements for the Stable Yard clearing and recording which will take place on Saturdays from 3<sup>rd</sup> August until both the yard and the remaining western wall are fully recorded. The NT would like the modern concrete on the yard surface to also be drawn in. Mrs Hutchins will confirm with Mr Turner regarding a day school drawing course. **Action: CH/BT**
  - c. **Binsted Pottery:** Mrs Gill Turner advised that a further day is planned at Worthing Museum on Thursday 18<sup>th</sup> July. Further sessions may be organised later in the year or next year for drawing and photographing the finds for inclusion in Dr Ben Jervis's report.
  - d. **Sompting:** After the recent successful dig, Mrs Shirley will be giving Mrs Lane a calling notice for work on Fridays at Malthouse Field for the newsletter. Mrs Shirley is giving a lecture to Pathfinders, and one to WAS in the autumn, and is writing an article for the annual journal. **Action: CS**
  - e. **Fittleworth:** Mrs Turner and Mr Bob Turner will be running the first of the planned flint identification mornings for the CDAS flint on Thursday 20<sup>th</sup> June at the finds shed. **Action: GT/BT**
  - f. **Brinsbury:** Mrs Turner advised that as the archaeological report will be published in the next issue of SAC this will need to include the Museum location of the site archive and finds. This is proving difficult to coordinate. It is Worthing Archaeological Society's position that the documentary Site Archive be deposited in Chichester Museum, and although the finds belong to the college, those not wanted by the college should also go to Chichester Museum with WAS paying for their deposition. Alternatively all the finds can be deposited in the Museum and the Museum can loan whatever is required to the college. Mr Brendan Wyatt will wait to see if Mr Pete Brannlund replies to Mrs Turner's email about his establishing with the college what it would like to do, and if there is no reply Mr Wyatt will contact Amy Roberts of Chichester Museum to agree with her the next step forward. **Action: BW/Chichester Museum**
  - g. **Records:** Mr Keith Bolton has the up-do-date spreadsheet. **Action: KB**

- h. **Amberley** - Mrs Connie Shirley forwarded the Surveyors Report to Mr Bolton but has not heard whether it has been formally submitted to Mr Robert Hutchinson. No fieldwalk has been arranged.

5. **Finance:** Mrs Shirley circulated up-to-date accounts. The Sompting dig has cost some money. Subscriptions are slightly down on last year but day schools are making a surplus. £300 remains in the Supplementary Expenses account (a donation fund for people who are unable to afford to attend WAS events). So far we have managed to fund any bursaries for WAS day schools from the overall cost of each course and it was suggested we send a notice in the newsletter to the effect that we will offer bursaries to attend other local courses (CDAS and BHAS) provided recipients pay a small contribution towards the cost and provide a report back to the newsletter. We unfortunately did not win a grant which would cover a new resistivity meter.
6. **Membership:** Mrs Lane advised that 92 members have paid for 2019 and there are 21 life members and 14 honorary members, making a total of 127 members.
